



## YOUNG CUP

### Junior Girl & Lady 4somes Knockout Competition 2018

#### Rules & Regulations of the Competition

1. A team shall consist of two players, one lady and one junior girl from the same club. The same lady and junior girl must play throughout the competition. There is no limit to the number of pairs a club may enter. **ENTRY DEADLINE SUNDAY 4 MARCH 2018**
2. A match shall consist of one round of foursomes. If after 18 holes the match is level, extra holes will be played. The winning team is the first team to win an extra hole. The winner of the match will go through to the next round.
3. All rounds must be played by the deadline dates – games should be arranged as early as possible to ensure sufficient time to agree dates. Common sense and flexibility must be applied at all times so that games can be played – the competition is about giving the girls as many opportunities to play as possible. **A walk-over (w/o) should be avoided.**
4. All matches to be played to a COMPETITION/ACTIVE CONGU handicap of limit 36. Number of strokes received/given is 1/2 the difference of the combined handicaps of the teams.
5. A player must be a bona fide member of the same club she represents and a member of the NLCGA. Players may only play for one club (disqualification for the offending player).
6. Participating clubs should give courtesy of the course for the matches – courtesy for practice rounds should not be expected.
7. The honour shall be decided by the toss of a coin.
8. The Home Team (H) shall be responsible for arranging the match by contacting the away team as early as possible and offering at least 3 dates, 1 of which must be a weekend. The dates should be spread over a reasonable period of time ie not consecutive or within a very short period of time. **Players must be mindful of the junior girls' school / college commitments including exam and school sports timetables.**
9. The winning team shall complete the result sheet and **send or email** it to the organiser:

10. R&A golf rules will be applicable. All queries and disputes must be referred to the Organiser. Final decisions will be made by the Organiser and CJO.
11. The final shall be played on a neutral course and will be arranged by the Organiser.  
**No practice round allowed on the final day of the competition nor must courtesy be expected for a practice round at the 'final' venue prior to the date of the final.**
12. No caddies are allowed.
13. The use of distance measuring devices is permitted in accordance with NLCGA rules.

Notes:

- a) *Junior Parental Consent Forms must be available at every match*
- b) *It is advisable that lady members make themselves aware of England Golf, Children in Golf Child Protection Policy and Guidelines which the NLCGA has adopted.*
- c) *Lady Team Members are asked to use their common sense in situations not covered by the above*
