## **JUNIOR GIRLS' COUNTY CHAMPIONSHIP** **TERMS OF THE COMPETITION**

### **1. ENTRY CONDITIONS**

- a. Only JUNIOR members of the NLCGA are eligible to enter who are under 18 years or under on 1<sup>st</sup> January in the year of the competition.
- b. Players must have a Handicap Index of 24.0 or less issued from a 'Golf Club' (as defined in the Rules of Handicapping Book) that is authorised to use the Rules of Handicapping.
- c. A player must have submitted five cards within the previous 12 months prior to the championship being played. It is the player's responsibility to ensure they meet the qualifying criteria.
- d. Junior Championship will consist of one round of 18-hole stroke play format.
- e. The stroke allowance is 95% of the course handicap on the course being played.
- f. If the competition is oversubscribed higher handicaps will be placed on a waiting list in handicap order.
- g. Players will be mainly drawn in handicap order.
- h. No refund of entry fees will be given for cancellation within 14 days of the event.
- i. Any cancellations should be advised to the Championship Organiser as soon as possible.
- j. In the event of adverse conditions, the Championship Organiser reserve the right to alter the format of the competition in order to achieve a result.

### **2. GENERAL CONDITIONS**

- a. The competition shall be played in accordance with the Rules of Golf as approved by the Royal and Ancient Golf Club of St Andrews and Local Rules as approved by the Championship Organiser.
- b. Distance measuring devices are permitted in accordance with the Rules of Golf (Rule 4-3).
- c. The player with the lowest gross score will be awarded with the Junior Championship Trophy
- d. Ties will be decided by card countback.
- e. A Handicap event shall be run over 18 holes in conjunction with the Championship and a Trophy awarded to the lowest net score. Handicap prizes will be awarded subject to number of entries.
- f. Individuals may receive more than one trophy, but MAY NOT receive more than one prize.
- g. All trophies will be held for one year and the responsibility for engraving shall lie with the NLCGA.
- h. The Championship Organiser reserves the right to arrange and/or alter starting times.
- i. If a player arrives at her starting point, ready to play, within five minutes after her starting time, the penalty for failure to start on time is two strokes at the first hole. Penalty for lateness beyond five minutes, in the absence of circumstances that warrant the waiving of the penalty under the Rules of Golf (Rule 5-3), is disqualification.
- j. In all matters the decision of the Championship Organiser is final.
- k. Motorised buggies are permitted subject to the Transportation Policy of NLCGA.
- l. Caddies are not permitted. The NLCGA does NOT allow spectators to walk on the fairways or speak to the players during the competition.
- m. Mobile phones are permitted but MUST be set to silent and only used for GPS and emergency calls.
- n. The Dress Code of the host Club must be adhered to.
- o. Player profile and consent form must be submitted before play starts.

## **BIRDIE CHAMPIONSHIP**

### **TERMS OF THE COMPETITION**

#### **1. ENTRY CONDITION**

- a. Only JUNIOR members of the NLCGA are eligible to enter who are Under 18 years or under on 1<sup>st</sup> January in the year of the competition.
- b. Players must have a Handicap Index of 24.1-40.0 issued from a 'Golf Club' (as defined in the Rules of Handicapping Book) that is authorised to use the Rules of Handicapping.
- c. Birdie Championship will consist of one round of 18-hole stableford format.
- d. The stroke allowance is 95% of the course handicap on the course being played.
- e. Players will be mainly drawn in handicap order.
- f. Any cancellations should be advised to the Competition Organiser as soon as possible.
- g. In the event of adverse conditions, the Competition Organiser reserve the right to alter the format of the competition in order to achieve a result.

#### **2. GENERAL CONDITIONS**

- a. The competition shall be played in accordance with the Rules of Golf as approved by the Royal and Ancient Golf Club of St Andrews and Local Rules as approved by the Competition Organiser.
- b. Distance measuring devices are permitted in accordance with the Rules of Golf (Rule 4-3).
- c. Ties will be decided by card countback.
- d. The Competition Organiser reserves the right to arrange and/or alter starting times.
- e. In all matters the decision of the Competition Organiser is final.
- f. Motorised buggies are permitted subject to the Transportation Policy of NLCGA.
- g. Caddies are not permitted. The NLCGA requests spectators refrain from walking on the fairways and from speaking to players during the competition.
- h. Mobile phones are permitted but MUST be set to silent and only used for GPS and emergency calls.
- i. The Dress Code of the host Club must be adhered to.
- j. Player profile and consent form must be submitted before play starts.
