TERMS OF COMPETITION

Young Cup 2024

ENTRY CONDITIONS

- 1. The competition shall be open to members of affiliated clubs to NLCGA and to players whose home club is in Norfolk.
- 2. A team shall consist of two players, one lady and one junior girl from the same club. Once a pair has played their 1st round, the same pair must continue to play throughout the competition. Players may only play for one club (disqualification for the offending player).
- 3. There is no limit to the number of pairs from each club.
- 4. Players must have a Handicap Index of 36.0 or less issued from a 'Golf Club' (as defined in the Rules of Handicapping Book) that is authorised to use the Rules of Handicapping.
- 5. The Lady player must have submitted any 5 cards in the previous 12 months prior to the match being played. It is the players responsibility to ensure they meet the qualifying criteria. Failure to comply will result in disqualification.
- 6. Entry closing date is Sunday 10th March 2024

COMPETITION CONDITIONS

- 1. The competition will be played in accordance with the Rules of Golf as approved by the Royal and Ancient Golf Club of St Andrews and Local Rules as may be approved by the Competition Organiser.
- 2. A match shall consist of one round of foursomes and played to a finish. If, after 18 holes, the match is level, extra holes will be played. The winning team is the first team to win an extra hole and will go through to the next round.
- 3. The stroke allowance is half the difference between the aggregate course handicaps of each pair on the course being played.
- 4. All rounds must be played by the end of the deadline dates games should be arranged as early as possible to ensure sufficient time to agree dates. Common sense and flexibility must be applied at all times so that games can be played the competition is about giving the girls as many opportunities to play as possible. A walk-over (w/o) should be avoided.
- 5. Participating clubs should give courtesy of the course for the matches courtesy for practice rounds should not be expected.
- 6. The honour shall be decided by the toss of a coin.

- 7. The Home Team (H) shall be responsible for arranging the match by contacting the away team as early as possible and offering at least three dates, one of which must be a weekend. Dates should be spread over a reasonable period, ie not consecutive or within a very short period of time. Players must be mindful of the junior girls' school/college commitments including exam and school sports' timetables.
- 8. The winning team shall complete the result sheet and send or email it to the organiser: Karen Young, 16 Stanmore Road, Norwich NR7 0HB e-mail: kby244@gmail.com Tel: 01603 433067
- 9. The final shall be played on a neutral course and will be arranged by the Organiser. Courtesy must not be expected for a practice round at the 'final' venue prior to the date of the final. On the day of the Final, no practice round or any holes are to be played on the course where the final is being held. Holes may be walked Penalty is disqualification of offending pair.
- 10. No caddies are allowed. Distance measuring devices are permitted in accordance with the Rules of Golf (Rule 4-3).
- 11. Motorised buggies are permitted subject to the Transportation Policy of the NLCGA.
- 12. Mobile phones are permitted but MUST be set to silent and only used for GPS and emergency calls.
- 13. In all matters, the Competition Organiser's decision is final.

NOTES

- a) It is advisable that lady members make themselves aware of England Golf and NLCGA child protection policy/guidance.
- b) In line with GDPR, your contact details will only be used for the purpose of this event and will not be shared with any third parties.
- c)Everyone should be able to enjoy golf in a safe environment.
